Small entity 2 cards will do at no cost to us. Website interface to manage the cards, issue to Dr. Hunter and the other to MCHS so any staff going can take the card. You can go into interface and say on this day there can be charges not to exceed a certain amount. Card can be turned off and on. Before group goes on field trip they will need to do a Purchase order. If decided that account is going to be closed, reimbursement will be given back.
